：概要とまとめ

「結婚と家族に関する国際比較調査」実施にむけて、調査票内容のチェックと検討のためのプレテスト・ヒアリングを、平成15年12月6～7日に東京と仙台で実施した。ヒアリングは、それぞれの地点において、年齢、配偶関係、学歴、および就業状態の異なった女性11名、そして年齢、配偶関係、および学歴の異なった男性9名から成る、合計40名を対象に行われた。対象者による討論を円滑かつ効果的に行うため、ヒアリングは、男女別、さらに女性を年齢層別に3つのグループに分けて実施された。ヒアリング第1日の12月6日（土）午後は20～39歳の女性、第2日の12月7日（日）の午前は40～69歳の女性、そして12月7日（日）午後は20～69歳の男性を対象とした。

ヒアリングでは、まず調査票を対象者に記入してもらい、それに引き続いて、個別の質問それぞれについて、疑問点や問題点などを対象者に指摘してもらい、さらに必要とあれば、質問や回答肢の訂正・修正に関する意見を聞いた。そして最後に、調査への協力を促進し、回答率上げるために可能な工夫や準備について、対象者の率直な意見を募った。ここでは、調査票の挨拶状や調査実施に際して考えられる問題点などが話し合われた。このようなヒアリングの結果を基に、従来の調査票に添付する挨拶状に加えて、事前（調査実施直前）に、調査客体全員に調査に関する説明と挨拶のためのハガキを郵送すること、および当該調査についての紹介記事を新聞（全国紙）に掲載するよう努力することが決定された。
